- 12:00noon to 22:30pm
- (3) On Good Friday - 12:00noon to 22:30pm
- (4) On New Year's Eve, except on a Sunday – 11:00am to 23:00pm
- (5) On New Year's Eve on a Sunday – 12:00noon to 22:30pm
- (6) On Christmas day, as provided by the rules of the club and notified in writing by the chairman or secretary of the club to the licensing authority. The said hours shall:-
 - (i) Not exceed six and a half hours;
 - (ii) Not begin earlier than 12:00noon;
 - (iii) Not end later than 22:30pm;
 - (iv) Provide for a break of at least 2 hours, including 15:00pm to 17:00pm; and
 - (v) Not extend for more than three and a half hours after 17:00pm.
- (7) On New Year's Eve from the end of permitted hours on New Year's Eve to the start of permitted hours on the following day (or, if there are no permitted hours on the following day, midnight on 31st December).

- 2) The above restriction does not prohibit:
 - (i) During the first twenty minutes after the above hours the consumption of the alcohol on the premises;
 - (ii) During the first twenty minutes after the above hours, the taking of the alcohol from the premises unless the alcohol is supplied or taken in an open vessel;
 - (iii) During the first thirty minutes after the above hours the consumption of the alcohol on the premises by persons taking meals there if the alcohol was supplied as ancillary to the meals;
 - (iv) The supply to, or consumption by, any person of alcohol in any premises where they are residing.
