- (1) The supply of alcohol to members and bona fide guests;
- (2) The provision of regulated entertainment by way of the exhibition of film(s) (indoors only):
- (3) The provision of regulated entertainment by way of live music (including Karaoke), (indoors only);
- (4) The provision of regulated entertainment by way of recorded music (indoors only);
- (5) The provision of regulated entertainment by way of anything of a similar description to that falling within (3) and (4) above (indoors only); and
- (6) The provision of entertainment facilities for dancing (limited to Royal Bar only). (indoors only)



Times the certificate authorises the carrying out of qualifying club activities

- (1) The supply of alcohol to members and bona fide guests:-
 - Sunday's 12:00noon to 23:30pm;
 - Monday to Thursday 11:00am to 23:30pm;
 - Friday's 11:00am to 24:00midnight;
 - Saturday's 11:00am to 00:30am the following day; and
 - On Christmas Eve (24th December) and New Years Eve (31st December) 11:00am to 01:00am the following day.
- (2) The provision of regulated entertainment by way of the exhibition of film(s) on Fridays and Saturdays only 20:00pm to 23:00pm.
- (3) The provision of regulated entertainment by way live music and/or the provision of facilities for dancing:-
 - Sunday's 20:00pm to 23:00pm;
 - Friday's and Saturday's 20:00pm to 23:30pm;
 - On Christmas Eve (24th December) and New Years Eve (31st December) -20:00am to 01:00am the following day; and
 - ➤ On the Sunday preceding any Bank Holiday Monday 20:00pm to 23:30pm.
- (4) The provision of regulated entertainment by way of recorded music on any day 08:00am to 01:00am the following day.
- (5) The provision of regulated entertainment by way of anything of a similar description to live or recorded music:-
 - Sunday's 11:00am to 24:00midnight; and
 - Monday to Saturday 11:00am to 01:00am the following day.

The opening hours of the club

The certificated premises will close a maximum of thirty minutes following the end of permitted hours for the supply of alcohol.

Where the certificate authorises supplies of alcohol whether these are on and/or off supplies

Alcohol may be supplied for consumption **0N** and **OFF** the premises.

Annex 1 – Mandatory conditions

- (1) (i) The supply of any alcohol for consumption off the premises must be made at a time when the premises are open for the purposes of supplying alcohol, in accordance with the club premises certificate, to members of the club for consumption on the premises.
 - (ii) Any alcohol supplied for consumption off the premises must be in a sealed container.
- (2) Any alcohol supplied for consumption off the premises must be made to a member of the club in person.
- (3) (i) In respect of the exhibition of films, the admission of children (i.e. anyone aged under 18) must be restricted in accordance with any recommendation(s) made by the film classification body specified (as designated by S4 of the Video Recordings Act 1984 the British Board of Film Classification).
 - (ii) Where a film classification body is not specified, the admission of children must be restricted in accordance with any recommendation(s) made by the licensing authority.



Annex 2 - Conditions consistent with the club Operating Schedule

- (1) No qualifying club activities shall be undertaken except during permitted hours.
- (2) As regards the supply of alcohol, the above restriction does not prohibit:-
 - (i) During the first twenty minutes after the above hours the consumption of the alcohol on the premises;
 - (ii) During the first twenty minutes after the above hours, the taking of the alcohol from the premises unless the alcohol is supplied or taken in an open vessel;
 - (iii) During the first thirty minutes after the above hours the consumption of the alcohol on the premises by persons taking meals there if the alcohol was supplied as ancillary to the meals:
 - (iv) The supply to, or consumption by, any person of alcohol in any premises where they are residing.
- (3) Access to the certificated premises shall only be afforded to members and guests by a suitable security fob and/or door access system.
- (4) The committee of the club shall ensure that all employees and staff are briefed and aware of the objectives of the Licensing Act 2003 and the statutory requirements thereof.
- (5) (i) All bona fide guests of the club shall be recorded in a register provided specifically for that purpose. Guests shall only be admitted if signed in by a member.
 - (ii) Guests shall not be permitted to remain on the premises once the member who signed them in has left the premises.
- (6) The committee of club, and the employees thereof, shall ensure that no person who is or appears to be intoxicated, or who behaves in a disorderly manner, shall be served alcohol.
- (7) (i) Children shall only be permitted entry to and allowed to remain on the certificated premises if accompanied by a member or bona fide guest who is at least 18 years of age.
 - (ii) Notwithstanding the above, no child(ren) shall be permitted on the premises at any time after 19:30pm on any day, unless otherwise taking part in a family function (or similar event) with the permission of the committee.



- (iii) Notices of these rules of entry to the premises by children shall be displayed on each notice board in the certificated premises.
- (8) (i) During any period of live or recorded music, the committee of the club, or nominated representative thereof, shall regularly and proactively assess carry out a noise assessment of the area adjacent to the premises.
 - (ii) Noise assessments shall take place on all sides of the premises at the boundary of the nearest residential premises, and if audible, suitable and sufficient steps shall be taken to reduce noise from the premises to a level at which noise is no longer audible at the monitoring point(s).
- (9) Except for access and egress, all external doors and windows of the premises must be closed and kept closed between 22:00pm and the end of opening hours on any day.
- (10) Prominent, clear and legible notices shall be displayed at all exit doors requesting patrons and staff to leave the premises and area quietly. Staff shall verbally re-iterate this message to patrons as members and guests leave.
- (11) All external areas of the club premises shall be closed to members, guests and members of the public and remain closed (i.e. vacated) between 22:00pm and the end of the opening hours on any day.
- (12) During the final 30-minutes of the opening hours of the premises, the volume of recorded music shall be reduced such that it is at a background level.
- (13) Suitable and sufficient supplies of first aid equipment / materials must be made available to members, guests and members of the public on request. Dependant on the activities, events and risks at the premises, a suitably trained first aider or an appointed person for first aid must also be present on the premises at all times during licensable activities.




