 - (i) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - (ii) at a time when the designated premises supervisor does not hold a personal licence or his/her personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Annex 2 – Conditions consistent with the Operating Schedule

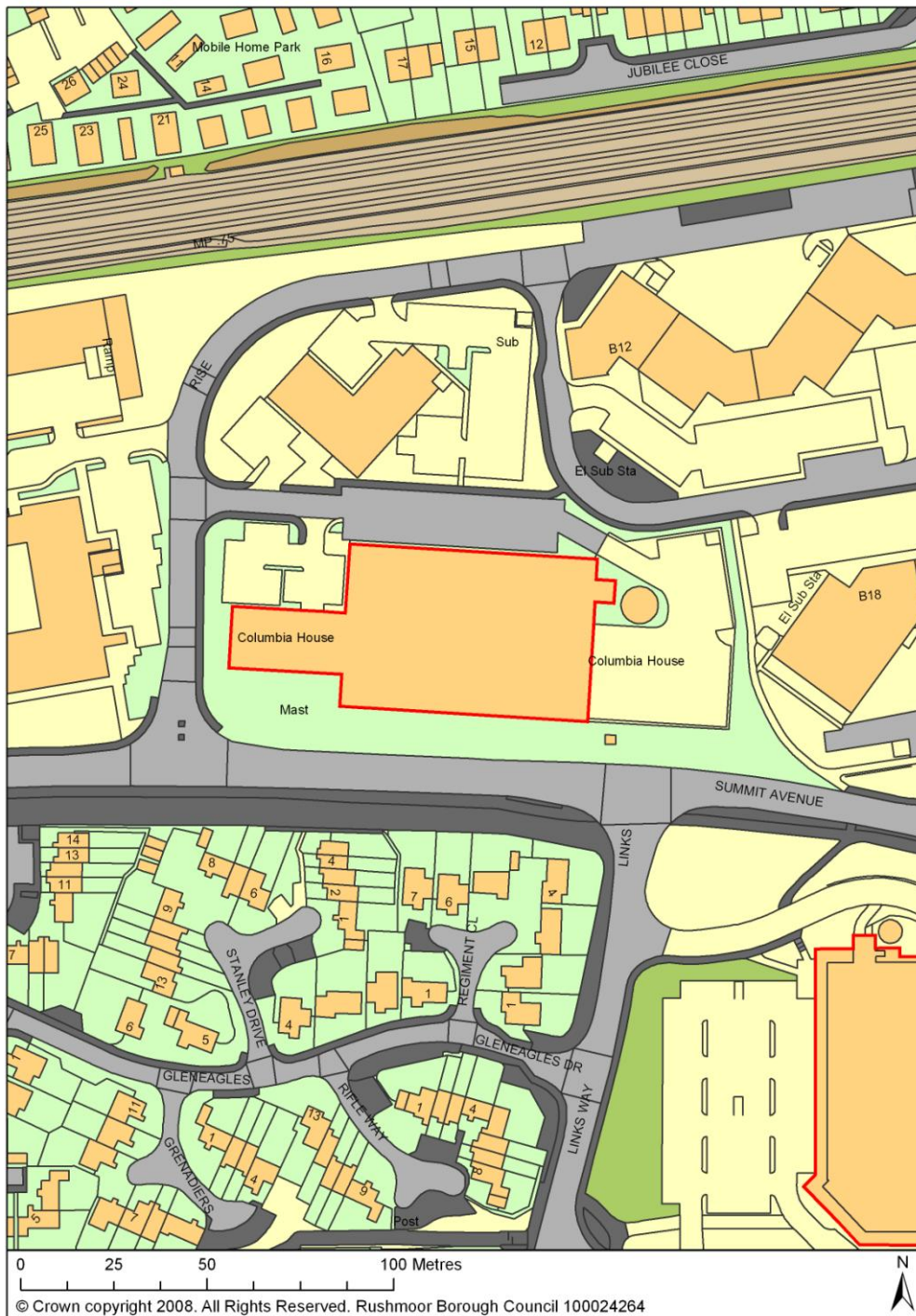
- (1) No licensable activities shall be undertaken except during permitted hours.
- (2) No alcohol shall be permitted to be consumed on the premises at any time.
- (3)
 - (i) Alcohol, including goods with alcohol content shall not be permitted to be collected from the premises by customers at any time.
 - (ii) Alcohol, including goods with alcohol content, shall always be despatched to the consumer delivery address.
- (4) No child(ren) and/or any other member of the public shall be permitted on the premises at any time.
