Annex 1 – Mandatory conditions

- (1) No supply of alcohol may be made under the premises licence:-
 - (i) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - (ii) at a time when the designated premises supervisor does not hold a personal licence or his/her personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- (3) (i) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
 - (ii) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

Annex 2 – Conditions consistent with the Operating Schedule

- (1) Alcohol may only be purchased by a member of Costco Wholesale UK Limited.
- (2) Proof of identity must be provided in order to apply for a Costco membership.
- (3)
 - (i) A suitable and sufficient CCTV camera system linked to a suitable recording facility shall, so far as is reasonably practicable, be operational at the premises during any period in which licensable activities are permitted.
 - (ii) CCTV recordings and footage must be retained for a minimum period of 31 days and be made available for review by the Police upon request (subject to the requirements of the Data Protection legislation in force at the time).
 - (iii) The system will display on any recording the correct time and date of the recording.
- (4) So far as is reasonably practicable, the licence holder will maintain adequate levels of staff and security personnel, and information regarding these levels shall be made available to the local authority and the Police upon request.
- (5) No persons under the age of 18 (eighteen) years shall be permitted onto the premises unless accompanied by a responsible adult.
