Annex 1 – Mandatory conditions

- (1) (i) In respect of the exhibition of films, the admission of children (ie: anyone aged under 18) must be restricted in accordance with any recommendation(s) made by the film classification body specified (as designated by S4 of the Video Recordings Act 1984 - the British Board of Film Classification).
 - (ii) Where a film classification body is not specified, the admission of children must be restricted in accordance with any recommendation(s) made by the licensing authority.



Annex 2 – Conditions consistent with the Operating Schedule

- (1) Any event will not preclude an individual or business who holds a street trading consent or tables & chairs permit within the licensed area from operating in accordance with that consent or permit.
- (2) The shopping centre manager shall be notified prior to any licensable activities taking place. For events involving multiple licensable activities all retailers in the scope of the licence shall be notified at least two weeks before the event.
- (3) A suitable and sufficient event management plan shall be submitted to the licensing authority at least four weeks before any event involving licensable activities. This timescale may be reduced with written approval from the licensing authority in conjunction with the responsible authorities for smaller events.
- (4) Where vehicles require access to any pedestrianised area within the scope of this licence, the event manager will liaise with local parking and highways authorities and adhere to all safety regulations.
- (5) Suitable and sufficient crowd control measures shall be in place in the area where any regulated entertainment is taking place.
- (6) For any event involving licensable activities, suitable and sufficient safety certification, by a competent person, shall be held by the event management, covering the installation and use of all temporary structures. This certification shall be made available to representatives of the Responsible Authorities on request.
- (7) Dependent on the activities, events and risks at the premises, a suitably trained first aider must be present during licensable activities.
- (8) The licence holder or nominated representative(s) shall carry out regular noise assessments of the area adjacent to the premises at the boundary of the nearest residential premises while regulated entertainment is taking place. Steps shall be taken to reduce the level of noise where it is likely to cause a nuisance to local residents.
- (9) There shall be a procedure in place for responding to noise complaints. Written records of all noise complaints and action taken in response shall be kept and made available to officers from Rushmoor Borough Council on request.
- (10) All areas within the scope of this licence shall be cleared of litter, including waste arising from smoking activities, on the conclusion of any event involving licensable activities.



- (11) (i) A noise management plan shall be submitted to the environmental health team at Rushmoor Borough Council at least four weeks prior to any event. No regulated entertainment shall take place without prior approval of the noise management plan by the pollution control team.
 - (ii) For small events the pollution control team may agree in writing that the noise management plan can be submitted up to one week before the event.
- (12) All events shall be family focussed and no adult entertainment shall be permitted at any time.




