Annex 1 – Mandatory conditions

- (i) The supply of any alcohol for consumption off the premises must be made at a time when the premises are open for the purposes of supplying alcohol, in accordance with the club premises certificate, to members of the club for consumption on the premises.
 - (ii) Any alcohol supplied for consumption off the premises must be in a sealed container.
- (2) Any alcohol supplied for consumption off the premises must be made to a member of the club in person.
- (3) Where one or more individuals must be at the premises to carry out a security activity (within the meaning of the Private Security Industry Act 2001), each individual must be licensed by the Security Industry Authority (SIA).



Annex 2 – Conditions consistent with the club Operating Schedule

- (1) No qualifying club activities shall be undertaken except during permitted hours.
- (2) As regards the supply of alcohol, the above restriction does not prohibit:-
 - (i) During the first twenty minutes after the above hours, the consumption of the alcohol on the premises;
 - (ii) During the first twenty minutes after the above hours, the taking of alcohol from the premises, unless the alcohol is supplied or taken in an open vessel;
 - (iii) During the first thirty minutes after the above hours, the consumption of the alcohol on the premises by persons taking meals there if the alcohol was supplied as ancillary to the meals; and
 - (iv) The supply to, or consumption by, any person of alcohol in any premises where they are residing.
- (3) The premises shall remain open for thirty minutes following the cessation of the supply of alcohol. This thirty-minute period shall be for sale of non-alcoholic beverages, drinking up and the use of lavatories only.
- (4) (i) The use of amusement with prizes (AWP) machines shall be restricted to individuals aged 18 or over only. This shall be actively enforced at all times.
 - (ii) All amusement with prizes machine(s) shall be situated in such locations that enable their use to be monitored by the club steward, committee members and/or bar staff at all times.
- (5) (i) The main entrance door to the club premises shall be monitored by a suitable and sufficient CCTV system.
 - (ii) Admission to the club shall be confined to members of the club and bona fide guests.
 - (iii) Admission to the club shall be controlled / supervised by the club steward(s), bar staff and committee members.
- (6) Suitable and sufficient supplies of first aid equipment / materials must be made available to members, guests and members of the public on request. Dependant on the activities, events and risks at the premises,



a suitably trained first aider or an appointed person for first aid must also be present on the premises at all times during licensable activities.

- (7) Except for access and egress, all external doors and windows of the premises must be closed and kept closed between 22:00pm and the end of opening hours on any day.
- (8) (i) No music or speech shall be relayed via external speakers other than for events with the prior approval of the licensing authority.
 - (ii) Except where otherwise approved in accordance with the above, speakers and other such amplification equipment shall be kept within the premises and shall not be positioned near to or facing openings such as doors and windows.
 - (iii) All speakers and similar amplification equipment shall be mounted on suitable anti-vibration mountings.
- (9) (i) All sound amplification systems shall be played through a suitable sound-limiting device.
 - (ii) In respect of the above, the sound level shall be set either at a level that ensures that noise form the premises is inaudible at the boundary of the nearest residential premises on all sides of the premises, or at a level agreed with Environmental Health Services at Rushmoor Borough Council.
- (10) (i) The licence holder or a nominated responsible representative(s) shall carry out a regular noise assessment of the area adjacent to the premises whilst licensable activities are taking place.
 - (ii) Noise assessments shall take place on all sides of the premises at the boundary of the nearest residential premises, and if audible, steps shall be taken to reduce noise from the premises to a level where noise is no longer audible at the monitoring points.
 - (iii) These assessments should be undertaken at half hourly intervals from 22:00pm until the end of permitted opening hours.
 - (iv) Written records of these assessments and any remedial action(s) taken shall be kept and made available to either the local authority or the Licensing Authority on request.
- (11) Notwithstanding conditions (9) and (10) above, the volume of recorded music shall be reduced to background level(s) during the final 30-minutes of the opening hours of the premises.
- (12) (i) Prominent, clear and legible notices shall be suitably located at all exits of the premises requesting members, guests and staff to



respect the needs of local residents and to leave the premises and area quietly.

- (ii) So far as is reasonably practicable, members and bona fide guests shall actively be reminded on leaving the premises to respect the needs of local residents and to leave the premises and area quietly.
- (13) (i) Suitable and sufficient exterior lighting shall be provided to the car park area of the premises.
 - (iii) All lighting including external lighting and lights activated by sensors shall be correctly adjusted so that they only illuminate the surface(s) intended and do not unreasonably throw light onto neighbouring property.
 - (iv) External lights shall be provided with properly designed screens, baffles, hoods and louvers to control the beam.
 - (v) All external lights shall be turned off when the premises are not being used to provide licensable activities.
- (14) (i) Suitable and sufficient notices shall be displayed within the premises requesting members, guests and staff to dispose of litter responsibly.
 - (ii) Suitable and sufficient litterbins shall be provided within the premises and/or the exits to assist with the above.
 - (iii) The area in the immediate vicinity of the premises shall be cleared of litter on a regular basis and always at the close of business.
- (15) All toilets at the premises shall be checked at hourly intervals and cleaned as necessary.
- (16) (i) Children (under 18) not accompanied by a member who is an individual aged 18 or over shall not be permitted in or to remain on the premises at any time.
 - (ii) Children under the age of 16 years shall not be permitted to enter the snooker room of the premises unless they are accompanied by a member who is an individual aged 18 or over.
 - (iii) Prominent, clear and legible notices shall be displayed at the bar detailing the above policies concerning children.



- (17) (i) All committee members and other relevant persons shall be made aware of the conditions of this licence by a mechanism in writing.
 - (ii) Club management, steward(s) and bar staff shall be given suitable and sufficient information on the requirements of the Licensing Act 2003 to a level commensurate with their role(s), responsibilities and duties.
- (18) (i) Subject to condition (1) in Annex 3, external areas shall only be available for the use of smokers and only for smoking purposes after 23:00pm on any day.
 - (ii) No licensable activities, food and/or drink (including alcohol) shall be permitted in external area after 22:30pm on any day.
 - (iii) Prominent, clear and legible notices shall be displayed at all exits from the club premises detailing the above restriction(s).
- (19) The use of any seating in the external drinking areas is prohibited after 23:00pm on any day.
- (20) (i) The area in the immediate vicinity of the premises shall be cleared of litter, including waste arising from smoking activities, on a regular basis and always at the close of business each day.
 - (ii) Suitable and sufficient litterbins shall be provided for the disposal of litter, including waste arising from smoking activities, within the premises and / or at the exits of the premises to assist with this requirement.




Annex 3 – Conditions attached after a hearing by the licensing authority

- (1) (i) With the exception of Friday's, Saturday's and permitted nonstandard days ONLY, all garden / external drinking areas shall be closed and vacated between 22:00pm and the end of opening hours on any day. Existing patrons in the area at this time shall be asked to leave the area quietly.
 - (ii) For the avoidance of doubt, permitted non-standard days in respect of this condition shall be taken to mean Christmas Eve, Christmas Day, New Years Eve, New Years Day, Bank Holiday Sundays, Bank Holiday Mondays and the Club Christmas Draw Night.
- (2) Disposal of refuse such as waste bottles into external receptacles, where the noise may be audible to neighbouring properties, shall not occur between 23:00pm and 08:00am Monday to Saturday and, 23:00pm and 10:00am Sunday's.
- (3) Prominent, clear and legible notices shall be suitably displayed in the car park of the premises requesting taxi drivers not to sound their horns at any time.
