Annex 1 – Mandatory conditions

(1) No supply of alcohol may be made under the premises licence:-

- (i) at a time when there is no designated premises supervisor in respect of the premises licence, or
- (ii) at a time when the designated premises supervisor does not hold a personal licence or his/her personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- (3) (i) The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
 - (ii) For the purposes of this condition, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children –
 - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to
 - drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
 - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act);
 - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less;
 - (d) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on –
 - (i) the outcome of a race, competition or other event or process, or



- (ii) the likelihood of anything occurring or not occurring;
- (e) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.
- (4) The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- (5) The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.
- (6) (i) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
 - (ii) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.
- (7) The responsible person shall ensure that -
 - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures –
 - (i) beer or cider: ¹/₂ pint;
 - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - (iii) still wine in a glass: 125 ml; and
 - (b) customers are made aware of the availability of these measures.



Annex 2 – Conditions consistent with the Operating Schedule

- (1) No licensable activities shall be undertaken except during permitted hours.
- (2) The premises shall remain open for 30 minutes following the last sale of alcohol during permitted hours. This period may be used for drinking-up and the use of lavatories only.
- (3) The licence holder shall take suitable and sufficient steps to ensure that troublemakers are not permitted to enter or remain on the premises.
- (4) The licence holder shall ensure that a suitable and sufficient number of bar staff are available at all times.
- (5) So as to promote public safety, the licence holder shall ensure that all external areas of the premises are suitably and sufficiently lit during opening hours.
- (6) The licence holder shall ensure that only individuals aged 18 years or over are permitted in / or remain on the premises after 21:00pm.
- (7) Anyone authorised to sell or supply alcohol at the premises shall request and ensure sight of suitable identification, for proof of age, of any person appearing to them to be under the age of 18 (eighteen) and who is attempting to purchase alcohol. The sale of alcohol shall not be permitted to any such individual where appropriate proof is not produced.
- (8) Suitable and sufficient notices shall be located at all exits of the premises (including car park) requesting patrons to leave the premises and area quietly, to refrain from slamming car doors or causing any disturbance that may cause offence to neighbours.
- (9) A suitable and sufficient notice shall be displayed in the public house to remind staff to advise customers when leaving of the need to keep noise levels to a minimum.
- (10) (i) The licence holder or nominated staff representative(s) must carry out a regular noise assessment of the area adjacent to the premises whilst licensable activities by way of live or recorded music are taking place.
 - (ii) Noise assessments must take place at the boundary of the nearest residential premises, and if audible after 23.00pm, suitable and sufficient steps should be taken to reduce noise from the licensed premises to a level at which noise from the premises is no longer audible at the monitoring point(s).
- (11) The licence holder shall make available to members of the public adequate and appropriate supplies of first aid equipment / materials. An appointed person for first aid will also be present or a suitably trained first aider, dependent upon activities, events and risk.




Annex 3 – Conditions attached after a hearing by the licensing authority
