#### Annex 1 – Mandatory conditions

- (1) No supply of alcohol may be made under the premises licence:-
  - (i) at a time when there is no designated premises supervisor in respect of the premises licence, or
  - (ii) at a time when the designated premises supervisor does not hold a personal licence or his/her personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- (3) (i) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
  - (ii) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
  - (iii) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
    - (a) a holographic mark, or
    - (b) an ultraviolet feature.
- (4) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price. For the purposes of this condition –
  - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979
  - (b) "permitted price" is the price found by applying the formula –

P = D + (DxV)

Where -

- (i) P is the permitted price
- D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and



- V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
  - (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence
    - (i) The holder of the premises licence
    - (ii) The designated premises supervisor (if any) in respect of such a licence, or
    - (iii) The personal licence holder who makes or authorises a supply of alcohol under such a licence;
  - (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
  - (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
  - (f) Where the permitted price given by Paragraph (b) would (apart from the paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
  - (g) Paragraph (b)(ii) applies where the permitted price given by Paragraph (b) on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
  - (h) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.
- (5) (i) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
  - (ii) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities,



carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—

- (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to—
  - drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
  - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
- (6) The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- (7) The responsible person must ensure that—
  - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—



- (i) beer or cider:  $\frac{1}{2}$  pint;
- (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
- (iii) still wine in a glass: 125 ml;
- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.



#### Annex 2 – Conditions consistent with the Operating Schedule

- (1) No licensable activities shall be undertaken except during permitted hours.
- (2) All alcohol products shall be located and displayed from behind the main point of sale service counter where access can be adequately supervised, monitored and where necessary, controlled by staff.
- (3) Suitable and sufficient signage shall be displayed in the premises providing information as to the relevant age restrictions for purchase of any age-restricted products sold on the premises.
- (4) (i) All staff / employees shall be given suitable and sufficient training to a level commensurate with their role and responsibilities.
  - (ii) Staff training shall include (but not be limited to) the lawful sale of alcohol.
  - (iii) A suitable and sufficient written record of all staff training shall be maintained and be available for inspection on the premises on request.
- (5) Anyone authorised to sell or supply alcohol at the premises shall request and ensure sight of suitable identification, for proof of age, of any person appearing to them to be under the age of 25 (twenty-five) and who is attempting to purchase alcohol.
- (6) (i) A suitable record of refusals shall be maintained and shall show details of all incidents when the sale of alcohol is refused.
  - (ii) The record of refusals will be retained for at least 6 months and will be available for inspection by the Police or the Licensing Authority upon request.
- (7) (i) Children under 16 (sixteen) shall not be permitted in at any time unless they are accompanied by an adult.
  - (ii) Notwithstanding the above, children shall not be permitted in any area of the premises after 00:00am on any day.
- (8) A minimum of 3 (three) suitably trained members of staff must be working at the premises from 17:00pm whilst licensable activities are taking place.
- (9) (i) A suitable and sufficient CCTV camera system linked to a suitable recording facility shall, so far as is reasonably practicable, be



operational at the premises during any period in which licensable activities are provided.

- (ii) So far as is reasonably practicable, the CCTV camera system shall be maintained in good working order at all times.
- (iii) All CCTV recorded images and footage must, so far as is reasonably practicable, be of evidential standard / quality.
- (iv) The CCTV recorded images and footage must be made available to the police and/or licensing authority within 24 hours of request.
- (11) In the absence of the designated premises supervisor from the premises, the premises and the activities carried on there shall be supervised by a responsible individual aged 18 or over who has received suitable and sufficient training to a level commensurate with this role and its associated responsibilities.
- (12) Suitable and sufficient details of all accidents and incidents of crime and disorder shall be logged in a suitable logbook provided and maintained at the premises for this purpose.
- (13) Suitable and sufficient fire safety equipment shall be installed and adequately maintained on the premises.
- (14) A suitable and sufficient supply of free potable drinking water shall be made available to customers at all times.
- (15) (i) All speakers and other such amplification equipment shall be placed on suitable anti-vibration mountings.
  - (ii) However, no speaker(s) or any other amplification equipment shall be mounted on, hung from or otherwise affixed to the ceiling of the premises, whether or not placed on anti-vibration mounts.
- (16) (i) A suitable noise complaints procedure must be established and in operation at the premises (e.g. all staff must be familiar with the complaints procedure and any complaint(s) made in respect of the premises, its customers, staff and/or the activities carried on there must be investigated and remedied as soon as, and, so far as is reasonably practicable to prevent public nuisance).
  - (ii) Suitable written records (e.g. the nature of any complaint(s), action(s) taken in response, the date(s) and time(s) when any complaint was made, together with the name of the person(s) who handled the complaint) must be kept and made available to officers of Rushmoor Borough Council on request.
- (17) The entrance lobby to be have two separate sets of doors leading into the premises.



- (18) All external doors and windows to be closed when any regulated entertainment takes place.
- (19) Except for access and egress, all external doors and windows must be closed and kept closed between 22:00pm and the end of the specified opening hours on any day.
- (20) Prominent, clear and legible notices shall be displayed at all exits requesting patrons and staff to leave the premises and area quietly.
- (21) All public areas to be cleared of empty glasses and crockery on a regular basis.
- (22) Disposal of refuse such as waste bottles into external receptacles, where the noise may be audible to neighbouring properties, shall not occur between 23:00pm and 08:00am.
- (23) (i) Suitable and sufficient litterbins shall be provided at the entrance
  / exit of the premises for the disposal of waste arising from smoking activities.
  - (ii) The area in the immediate vicinity of the premises shall be cleared of litter, including waste arising from smoking activities, on a regular basis and always at the close of business each day.
- (24) All staff / employees shall be made aware of the conditions attached to this licence by a mechanism in writing.



#### Annex 3 – Conditions attached after a hearing by the licensing authority

- (1) No smoking activities shall be permitted at the front of the premises on Station Road whilst the premises are open.
- (2) (i) The licence holder or a nominated representative shall carry out a regular noise assessment of the area adjacent to the premises. These assessments shall be undertaken at 30 minute intervals from 23:00pm.
  - (ii) Noise assessments shall take place on all sides of the premises at the boundary of the nearest residential premises, and if audible, steps shall be taken to reduce noise from the premises to a level where noise is no longer audible at the monitoring points.
  - (iii) Suitable written records of noise assessments and any remedial actions taken shall be kept and made available to officers of Rushmoor Borough Council on request (e.g. the date(s) and time(s) when any assessment was made, the location of the assessment(s), the findings of each assessment, any action(s) taken in response, together with the name of the person(s) who made the assessment(s) or took remedial action).
- (3) So far as is reasonably practicable, staff shall verbally reiterate the requirement for customers to leave the premises and surrounding area quietly when they leave the premises
