Annex 1 – Mandatory conditions

No supply of alcohol may be made under the premises licence:-

- (i) at a time when there is no designated premises supervisor in respect of the premises licence, or
- (ii) at a time when the designated premises supervisor does not hold a personal licence or his/her personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- (3) (i) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
 - (ii) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
 - (iii) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
 - (a) a holographic mark, or
 - (b) an ultraviolet feature.
- (4) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price. For the purposes of this condition –
 - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979
 - (b) "permitted price" is the price found by applying the formula –

$$P = D + (DxV)$$

Where -

(i) P is the permitted price



- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
 - (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence
 - (i) The holder of the premises licence
 - (ii) The designated premises supervisor (if any) in respect of such a licence, or
 - (iii) The personal licence holder who makes or authorises a supply of alcohol under such a licence;
 - (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
 - (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
 - (f) Where the permitted price given by Paragraph (b) would (apart from the paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
 - (g) Paragraph (b)(ii) applies where the permitted price given by Paragraph (b) on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
 - (h) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.



Annex 2 – Conditions consistent with the Operating Schedule

- (1) (i) Anyone authorised to sell alcohol at the premises shall (before being permitted to make sales of alcohol) be suitably trained in respect of the following matters to a level commensurate with their duties and responsibilities:-
 - (a) the refusal of the sale of alcohol to those who appear intoxicated and how to recognise them; and
 - (b) the appropriate precautions to prevent the sale of alcohol to persons under the age of 18.
 - (ii) Refresher training shall take place at least every 12 months
 - (iii) All staff / employees shall be trained regarding appropriate precautions to prevent the sale of alcohol to persons under the age of 18, the below and work to a Challenge 25 policy.
- (2) Anyone authorised to sell or supply alcohol at the premises shall request and ensure sight of suitable identification, for proof of age.
 - (ii) For the purposes of this condition, suitable identification is photo driving licence, passport, or any other photographic identification bearing the "PASS" logo and the person's date of birth.
 - (iii) Further to the above, anyone authorised to sell or supply alcohol at the premises shall be instructed that no sale of alcohol shall be made unless suitable identification, for proof of age, can be provided.
- (3) Alcohol shall only be delivered to a legitimate address that is a dwelling or business premise
- (4) (i) The delivery driver shall ensure that for every transaction including alcohol, which has not been pre-paid for by credit card, that photographic ID proving that person to be over the age of 18 years is produced.
 - (ii) The delivery driver shall record in writing or electronically the date of birth and the Passport number, photo driving licence number or PASS accredited photo ID number. These details shall be corroborated with the original order for alcohol. If the person seeking alcohol is unable to produce acceptable means of identification, or the details cannot be corroborated with the original



order, no sale or supply of alcohol will be made to or for that person. These records shall be made available to responsible authority's on request.

- (iii) Further to the above all alcohol shall be left in the delivery vehicle until the above identity criteria have been met.
- (5) (i) A written log shall be kept of all refusals including refusals to serve alcohol. The holder of the premises licence shall ensure that the refusals log is properly maintained and this shall involve, but is not limited to, nominating in writing a responsible person to check and sign it on a weekly basis.
 - (ii) The record of refusals will be retained for at least 12 months and will be available for inspection by the Police or the Licensing Authority upon request.
- (6) Orders which include alcohol may only be collected between the hours of 8:00am and 18:00pm.
- (7) No sales of alcohol shall be made directly at the premises.
- (8) Alcohol must be kept in a locked and secure unit.
- (9) Only beer and/or wine will be made available to purchase. No spirits and/or liquors shall be available to purchase.



Annex 3 – Conditions attached after a hearing by the licensing authority

- (1) No alcohol will be delivered after 23:00 hours on any day.
- (2) Alcohol will only be sold as part of a food order that has been preordered.
- (3) Delivery drivers operating from or on behalf of the premises shall not leave their vehicle engines running or idling at any time when not in motion and/or parked in the vicinity of the premises or customer address.
- (4) Any customer collecting an order shall be reminded to park in a nearby car park and be considerate of local residents near to the premises
