- In the absence of adequate daylight, artificial lighting in any area accessible to the public shall be fully operational whilst the public are present.
- All external doors and windows shall be maintained in good order.
- All the rubbish produced by the premises shall be stored securely in a designated area or in a bin with a tight fitting and lockable lid.
- A sufficient number of suitable receptacles must be located in appropriate locations for the depositing of waste materials such as food wrappings, drinks containers, etc. by customers.
- No fumes, steam or odours shall be emitted from the licensed premises so as to cause a nuisance to any persons living or carrying on business in the area where the premises are situated.
- Ventilation equipment will be regularly cleaned and maintained to control the levels of odour generated by the premises.
- When issues are identified approaches will be made to patrons, who will be asked not to stand around talking in the street outside the premises or any car park; and asked to leave the vicinity as quickly and quietly as possible.
