a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)

The licenseholder shall ensure that all time when the premises are for any licensable activity, there are sufficient competent staff on duty at the premises for the purpose of fulfilling the terms and conditions of the licence and for preventing crime and disorder. The licensee shall ensure that all staff will undertake training in their responsibilities in relation to the sale of alcohol. Record will be kept of training and refreshed training.

b) The prevention of crime and disorder

Any incidents of criminal or criminal nature that occur on the premises will be reported to the Police.
Install comprehensive CCTV coverage at premises and this. The CCTV system shall conform to the following points:
1 cameras must be sited to observe the entrance and exit door both side
2 Digital images must be kept for 31 days

c) Public safety

Appropriate fire safety procedures are in place including fire extinguishers (Foam, H2O and CO2), fire blanket, internally fire exit signs, numerous smoke detectors and emergency lighting (see enclosed plan for details of locations).
All emergency exits shall be kept free from obstruction at all times.

d) The prevention of public nuisance

All customers will be asked to leave quietly.
Clear and legible notices will be prominently displayed to remind customers to leave quietly and have regard to our neighbours.

e) The protection of children from harm

The licensee and staff will ask persons who appear to be under the age of 25 for photographic ID such as proof of age cards, the ¹⁸connections card and citizen card, photographic driving licence or passport, and official identity card issued by ¹⁷HM Forces or by any EU country.
