The name of the restaurant is SARANG located at 32 Union Street, Andover, Hampshire GU11 1EW. The restaurant will make Nepalese and Korean authentic foods and the menu will feature various dishes from these together with soft drinks, soft drinks and hard drinks (alcoholic drinks) for the customers. 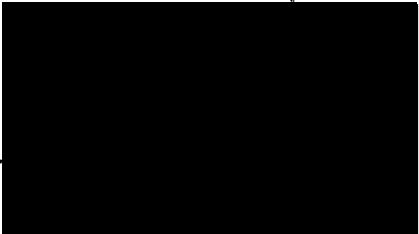

Describe the steps you intend to take to promote the four licensing objectives:

a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)

The Manager/DPS (Mr. Supan Pradhan) is an experienced person who has been working in Catering sector for the last 15 years. He fully understands his role and responsibilities concerning the four licensing objectives set out in the Licensing Act 2003. A comprehensive breakdown of these objectives and how to ensure they are met are detailed below. The manager/DPS of the premises shall ensure that all staff who work behind the bar have full knowledge of the challenge 25 Policy. The challenge 25 Policy poster will be prominently displayed at the counter and entrance to the premises.

b) The prevention of crime and disorder

① Any person who shows signs of intoxication will be refused entry into the premises. ② Appropriate digital CCTV equipment and sufficient number of cameras shall be installed at the premises to record colour images for the Police to investigate any crimes. ③ No person other than the Police, Licensing Authority, Premises License Holders shall have access to the CCTV recordings. ④ Recording made on the CCTV system shall be retained for a period of at least 31 days. ⑤ A notice of A4 size stating that CCTV is in operation shall be displayed in premises where the Police have access.

c) Public safety

① The authorised seating capacity shall not be exceeded. ② The external areas of the premises must be lighted well. ③ The management shall have a challenge 25 policy and bar staff and waiters shall be instructed not to serve anyone who fails to prove that they have reached 18 years of age. ④ A appropriate 'First Aid kit' shall be located on the premises and available for staff and customer's use.

d) The prevention of public nuisance

The management will control the escape of noises from the premises by ensuring that the windows and doors are kept shut during indoor events. ② Entry to the licensed premises will not be permitted to anyone who appears intoxicated. ③ The management fully understands that it is their duty to prevent their business from causing any nuisance to any local residents or businesses by anti-social behaviour or public nuisance.

e) The protection of children from harm

① Only children accompanied by adults will be allowed into the restaurant/licensed premises. They should be supervised by an adult at all times. The management shall adopt the Challenge 25 Policy. Any person who appears to look under the age of 25 shall be challenged and asked for identification to prove that they are over the age of 18. The premises shall only accept valid forms of identification with photos, such as, driving licence or passport etc. The Challenge a Refusal Checklist must be put in place at the counter for recording challenge and refusal incidents.

 - a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.

 - any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.

13. Where there is more than one applicant, each of the applicants or their respective agent must sign the application form.
14. This is the address which we shall use to correspond with you about this application.
15. Entitlement to work/immigration status for individual applicants and applications from partnerships which are not limited liability partnerships:

A licence may not be issued to an individual or an individual in a partnership which is not a limited liability partnership who is resident in the UK who:

- does not have the right to live and work in the UK; or
- is subject to a condition preventing him or her from doing work relating to the carrying on of a licensable activity.

Any licence issued in respect of an application made on or after 6 April 2017 will become invalid if the holder ceases to be entitled to work in the UK.

Applicants must demonstrate that they have the right to work in the UK and are not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity.

They do this in one of two ways:

- 1) by providing with this application, copies or scanned copies of the documents which an applicant has provided, to demonstrate their entitlement to work in the UK (which do not need to be certified) as per information published on gov.uk and in guidance.
- 2) by providing their 'share code' to enable the licensing authority to carry out a check using the Home Office online right to work checking service (see below).

Home Office online right to work checking service.

Your right to work will be checked as part of your licensing application and this could involve us checking your immigration status with the Home Office. We may otherwise share information with the Home Office. Your licence application will not be determined until you have complied with this guidance.
