Describe the steps you intend to take to promote the four licensing objectives:

a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)

I aim to promote responsible drinking by only selling alcohol with a food order, to discourage people who only want alcohol to visit our food business.
The Challenge 25 method will be applied to each sale of alcohol.
Alcohol will be served in cans not bottles. So no chance of broken glass.
Extra bins for can recycling will be placed on the premises.

b) The prevention of crime and disorder

We will have cctv in place to deter any people from committing any crimes.

c) Public safety

Our aim is to provide the opportunity for our customers to enjoy a drink or two with their food orders, we are aiming to attract the sort of customers that enjoy the taste of their drink when paired with their food rather than the customer who wants to get drunk.

d) The prevention of public nuisance

With the help of cctv, Extra bins for the cans and a keen eye, I can keep away the type of customer who might cause a public nuisance. We will encourage people to keep the noise to a minimum. (Already have signs in place doing so)

e) The protection of children from harm

Along side the cctv and by looking out for certain behaviour, a rule of buying food with alcohol, will deter people from buying too many drinks to a point of being impaired. Which in tum will prevent drunk people behaving inappropriately around children.
