Annex 2 – Conditions consistent with the Operating Schedule

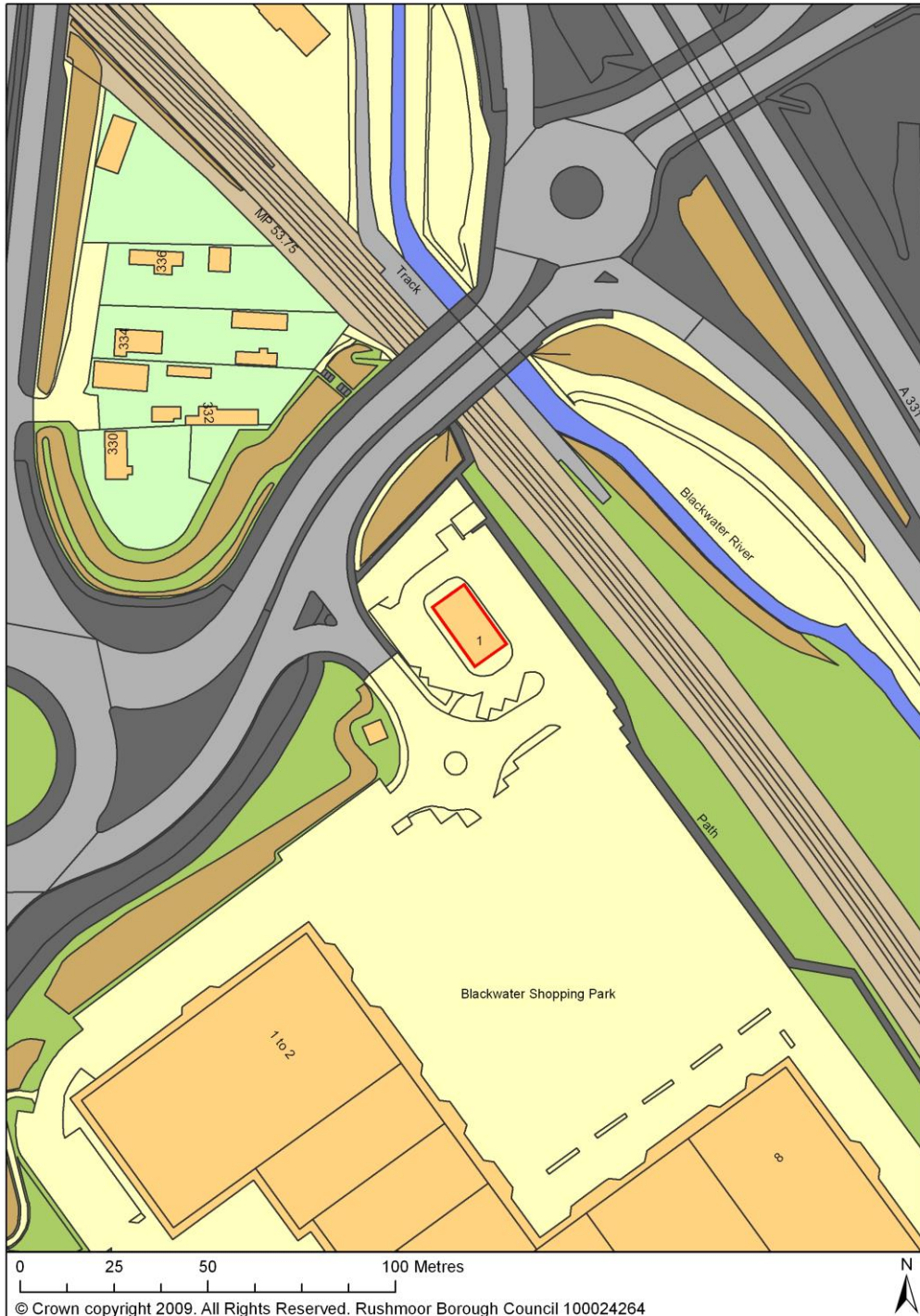
- (1) No licensable activities shall be undertaken except during permitted hours.
- (2)
 - (i) A suitable and sufficient CCTV camera system shall be operational at the premises whilst they are open to the public.
 - (ii) All cameras must be maintained in good working order at all times.
 - (iii) Access to the CCTV system shall be provided immediately upon request by any authorised police constable or Council officer.
- (3) The footpath immediately outside the front of the premises shall be kept clear of all litter emanating from the premises.
- (4) Children's parties (or similar) shall not be held during any period when licensable activities are being undertaken.
- (5)
 - (i) The area in the immediate vicinity of the premises shall be cleared of litter, including waste arising from smoking activities, on a regular basis, and always at the start of each working day.
 - (ii) In doing so, all litter on public footpaths and public land within a radius of 100 metres of the premises, shall be cleared and disposed of appropriately.
