Annex 1 – Mandatory conditions

- (1) No supply of alcohol may be made under the premises licence :-
 - (i) At a time when there is no designated premises supervisor in respect of the premises licence, or
 - (ii) At a time when the designated premises supervisor does not hold a personal licence or his/her personal licence is suspended.
- (2) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation *to the premises*.
- (3) in this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—
 - (i) Games or other activities which require or encourage, or are designed to require or encourage, individuals to—
 - (a) Drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - (b) Drink as much alcohol as possible (whether within a time limit or otherwise);
 - (ii) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
 - (iii) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
 - (iv) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behavior or to refer to the effects of drunkenness in any favorable manner;



- (v) Dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
- (4) The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- (5) (i) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
 - (ii) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
 - (iii) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
 - (a) a holographic mark, or
 - (b) an ultraviolet feature.
- (6) The responsible person must ensure that—
 - (i) Where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
 - (a) beer or cider: ½ pint;
 - (b) gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - (c) still wine in a glass: 125 ml;
 - (ii) These measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
 - (i) Where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available."



- (7) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price. For the purposes of this condition –
 - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979
 - (b) "permitted price" is the price found by applying the formula –

$$P = D + (DxV)$$

Where -

- (i) P is the permitted price
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
 - (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence
 - (i) The holder of the premises licence
 - (ii) The designated premises supervisor (if any) in respect of such a licence, or
 - (iii) The personal licence holder who makes or authorises a supply of alcohol under such a licence:
 - (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
 - (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
 - (f) Where the permitted price given by Paragraph (b) would (apart from the paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be



taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

- (g) Paragraph (b)(ii) applies where the permitted price given by Paragraph (b) on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
- (h) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.



Annex 2 - Conditions consistent with the Operating Schedule

- (1) (i) Anyone authorised to sell or supply alcohol at the premises shall request and ensure sight of suitable identification, for proof of age, of any person appearing to them to be under the age of 25 (twenty-five) and who is attempting to purchase alcohol.
 - (ii) For the purposes of this condition, suitable identification is photo driving licence, passport, or any other photographic identification bearing the "PASS" logo and the person's date of birth.
 - (iii) Further to the above, anyone authorised to sell or supply alcohol at the premises shall be instructed that no sale of alcohol shall be made unless suitable identification, for proof of age, can be provided.
 - (iv) Suitable and sufficient warning signs shall be displayed in the premises providing information in respect of the above challenge 25 policy and the request for suitable identification in connection thereof.
- (2) All staff / employees shall be trained regarding appropriate precautions to prevent the sale of alcohol to persons under the age of 18, including the above Challenge 25 policy.
 - (i) Written records of all training and refresher training signed and dated by the member of staff who received that training shall be kept on the premises to which they relate for a minimum of 2 years.
 - (ii) Written records of such training shall be kept and made available to the responsible authorities on request.
- (3) (i) A written log shall be kept of all refusals, including refusals to serve alcohol. The holder of the premises licence shall ensure that the refusals log is properly maintained and this shall involve, but is not limited to, nominating in writing a responsible person to check and sign it on a weekly basis.
 - (ii)Written records of any refusals shall be maintained at the premises for 12 (twelve) months and be made available to the responsible authorities immediately on request.



- (4) All drivers shall be required to provide their date of birth when signing in.
- (5) All advertisements for the premises, shall clearly market it as a go karting venue. The sale of alcohol must be ancillary to this use.
- (6) Children under the age of 16 years shall not be permitted in the premises, unless they are accompanied by an adult (over 18 years).
- (7) (i) Alcohol will not be sold to any individual until after they have finished racing. A wristband system shall be in place to ensure nobody can drive karts after alcohol consumption.
 - (ii) Patrons who have finished racing are to be restricted to the bar/spectating areas. All alcohol shall be displayed in locked fridges behind the bar counter where only staff are permitted.
- (8) All alcohol kept in storage (i.e. not on the sales floor) at the premises shall be stored in a secure, locked area designated for this purpose.
- (9) Only a limited number of essential personnel shall have access to the alcohol stored there
- (10) Prominent, clear and legible notices shall be displayed at all exits of the premises requesting patrons and staff to respect the needs of local residents and to leave the premises and area quietly.
- (11) The bar will remain closed for the sale of alcohol during any event specifically for children.
