#### Annex 2 – Conditions consistent with the Operating Schedule

- All employees and staff at the premises shall be given suitable (1) (i) and sufficient training on how to appropriately manage problem / disruptive customers to a level commensurate with their duties and responsibilities.
  - Written records of all training signed and dated by the member of (ii) staff who received that training shall be kept on the premises to which they relate for a minimum of 2 years and be provided to the responsible authorities on request.
- (2) Alcohol shall not be consumed on the premises at any time.
- (3) Except for access and egress, all external doors and windows must be closed and kept closed between 23:00pm and the end of the opening hours on any day.
- (4) Prominent, clear and legible notices must be displayed at all exits of the premises requesting patrons and staff to respect the needs of local residents and to leave the premises and area quietly.
- Suitable and sufficient litterbins shall be provided within the (5) (i) premises and/or at the exits of the premises.
  - (ii) The area in the immediate vicinity of the premises shall be cleared of litter on a regular basis and always at the close of business.
